DON'T LET TRAINING SLIPPAGE BECOME A PROBLEM

Just in case you hadn't noticed, as of 10th September 2008, Driver CPC started. This means that for Bus & Coach companies by March 2009, 10% (6 months) of the first five years of Driver CPC has already gone! It would be interesting to see how many companies have already got 10% of the training completed.

The point to make here is that it is very easy in today's busy world to let training slip into the background. If this happens with Driver CPC it will be very hard to play catch up in the last few years.

Don't forget, on 10th September 2013 it will be illegal for drivers to drive commercially if they have not completed the appropriate training.
