



DRIVER CPC CONTRACT PROVISION FOR PERIODIC TRAINING

GENERAL

HOW THE CONTRACT WORKS

Choose the courses

Managers have a wide variety of courses to choose from. The breadth of choice available means that most needs can be met by our existing portfolio. Where specific needs exist, Specialist can design and gain approval for bespoke courses (as long as they can still be linked to the EU Directive Syllabus).

Choose when and where

Specialist is approved to deliver courses nationwide and has access to a large bank of approved trainers. Dates and locations can be arranged for at any time during the year which are agreed at the start of the contract for the training year and all parties involved are informed.

Send the drivers to the training

Confirmation of the training date and location will be sent in advance along with a reminder to drivers about bringing their driving licences and ID to the course. All learning materials, training aids, documentation etc are provided by Specialist. Attendance certification is issued to the drivers.

Leave the administration to Specialist

Managers are regularly kept up to date on which of their drivers have attended which course and their progress to Driver CPC completion. Any staff changes should be passed to Specialist as soon as possible so that the training programmes can be updated. Managers need to have no involvement with the DSA or JAUPT but will have complete access to their drivers' status at all times. All administration costs are included in the overall contract price.

THE FINANCIAL ADVANTAGES

A contract is booked to cover the first five years of Driver CPC. This doesn't just give a company the advantage of knowing when and where and what courses are being delivered. It also enables them to plan financially for five years. Specialist guarantees that the daily rate agreed in year one of the contract will remain the same for the duration of the contract with only the addition of an annual amount commensurate with the rate of inflation. In the last few years of Driver CPC when rates are likely to rise significantly, this could be no small saving! Obviously if there are any fee increases from the JAUPT for driver registration etc, these will be passed on at cost.
