FORK LIFT TRUCK

OPERATOR TRAINING

RTITB National Operator Registration Scheme (**NORS**) or **Certificate of Competence** courses are available for all your Fork Lift Truck Operator requirements. These are carried out at a ratio of **3 trainees to 1 instructor**. Training can take place at either our training centre in Altham or alternatively onsite at customer premises. Please call **0800 328 3297** to discuss your training requirements.

Trucks include counterbalance, reach, pedestrian pallet, pivot steer including flexi and bendi, very narrow aisle, order picker, side loader, vehicle mounted lift truck, scissor lift and cherry picker.

INSTRUCTOR / EXAMINER TRAINING

Specialist is an approved Centre for the delivery of RTITB Instructor/Examiner training. This ten day initial course aims to up-skill a member of staff to RTITB Instructor standard to prepare them to deliver accredited training.

We also offer **In-house Instructor**/**Examiner training**. This is suitable for organisations which require an instructional resource to deliver in-house training to employees. Once an individual is qualified, he or she will be able to instruct and examine on trucks for which they hold the relevant operator's certificate.

FIRST AID

Specialist Training has provided First Aid training for over 15 years and was approved by HSE. Since then we have become a member of the Federation of First Aid Training Organisations (FOFATO) and all our courses are approved by the First Aid Industry Body (FAIB).

FIRST AID AT WORK (FAW) - INITIAL - 3 DAYS

Suitable for all industry types with a requirement for full first aid certification, valid for three years.

FIRST AID AT WORK - RE-QUALIFICATION - 2 DAYS

This course is suitable for existing First Aid at Work qualified candidates who are looking to renew for a further 3 years. This course can be taken 3 months before the expiry date.

EMERGENCY FIRST AID AT WORK - 1 DAY

The Emergency First Aid at Work course is useful as backup for organisations that already have FAW provision. This course can also be counted as 7 hours of Driver CPC training.

AUTOMATED EXTERNAL DEFIBRILLATOR (AED) - 1/2 DAY

An introductory overview of the use of an AED (defibrillator) is now a compulsory part of our First Aid training, however if you require a more indepth course for a group of staff then we can provide this as a half day session.

CERTIFICATE OF PROFESSIONAL COMPETENCE (CPC)

All applicants for an Operator's Licence for **ROAD HAULAGE** or **PASSENGER CARRYING VEHICLES** must demonstrate "**professional competence**." The most popular way this is achieved is by passing the examination for the CPC conducted by OCR Examinations on behalf of the Department for Transport (DfT).

CPC INTENSIVE COURSE

This **ten day** intensive public course follows the **OCR Syllabus**, which is based directly on Regulation EC 1071/2009 and includes exam preparation for the two examinations that are held at our training centre, in September and March. Upon successfully passing the examinations, a certificate will be awarded by OCR. Results are published 8 weeks after the examination date.

If you have a **group** of more than **7 candidates** to train at the same time then it may be more **cost effective** if we come to you to deliver the training as an in-company course. These can be scheduled around the December 2017 exam. For further details please call **0800 328 3297** to discuss your requirements further.

CPC REFRESHER / REGULATORY UPDATE COURSE

This **one/two day** intensive course is designed to **up date** the **knowledge** of **existing transport managers** and other related transport professionals who already hold a CPC. Such training is **recommended** by the **Traffic Commissioners** as important in ensuring managers are "current" in their transport knowledge.

DANGEROUS GOODS

CARRIAGE OF DANGEROUS GOODS BY ROAD - ADR

This course is for drivers who transport regulated dangerous goods over certain load thresholds by road. Drivers have to attend an approved course and pass an examination set by SQA. Certificates are valid for 5 years both internationally and in the UK.

This course is modular and can include all classes of dangerous goods including Explosive and Radioactives. It can also count for up to a maximum of 28 hours of Driver CPC training depending on the modules attended.

Since Feb 2017 all ADR in-centre course exams have been held online. This has been hugely successful and beneficial to the driver especially as the results are issued at the end of the session and the ADR card published within 7 days.

ADR courses are generally carried out during the week however weekend courses are available on demand. If you would prefer an in-company course, where we can come to you then please call **0800 328 3297** to discuss your requirements.

This includes personnel involved with classification, packing, labeling and completing / signing off documentation. This CAA approved and certified course complies with the training requirements of the IATA Regulations. This course is suitable for initial and refresher candidates. Upon passing the course, trainees will be issued with a CAA approved Carriage of Dangerous Goods by Air certificate.

Driver CPC

The September 2019 deadline is fast approaching with only 2 years remaining for drivers to gain their 35 hours. As occurred in the first five year phase it is expected for the demand for Driver CPC to increase significantly over the next 2 years and it is highly recommended that our customers plan their training well before the 2019 deadline.

Specialist's Driver CPC courses cover a huge variety of subjects relevant to a driver's role. Our **Modular Course Programme** consists of **14 x 3.5 hour modules** which can be combined in pairs to make seven hour courses. Alternatively there are a number of stand-alone **7 hour programmes**. Courses meet the needs of both Passenger and Goods Vehicle drivers and are all approved by JAUPT.

A **NEW** module, '**Dealing with Emergencies**' has been added from September which will help the drivers deal with the most likely of emergencies whilst on the road. The First Aid module would be a complementry module to be added to the new course to create a 7 hour course.

PUBLIC

Our public courses are aimed at smaller organisations, or those that cannot release large numbers of drivers at the same time to attend training or for those drivers who have been unable to attend their in-company course. Public courses covers a wide range of subjects and are scheduled on pre set dates, allowing you to plan them into your operations.

IN-COMPANY

In-company courses are ideal for those companies who can release large numbers of drivers to attend training (up to 20 per course). The benefit of in-company courses is that they can be tailored to be specific to company needs and can be arranged at a location and date to suit. The customer can choose any of the existing courses available or if numbers permit, a course can be specifically designed for them. This option also makes it easier to achieve optimum course loading and thus maximises value for money costing from as low as \pounds 31.25 per person!

Driver Training

Specialist offers a number of solutions to the challenges of **driver improvement**. These range from simple **driving assessments** to a completely **integrated training programme**.

LARGE/MEDIUM GOODS FAMILIARISATION TRAINING

This training is designed to familiarise those individuals who have historically held an LGV licence category but who have rarely, or never used it. The course trains or refreshes these drivers in all aspects of safe driving for the particular licence category. On completion of this course the driver will feel more **confident** carrying out their duties. An appropriate vehicle must be provided by the customer.

LICENCE ACQUISITION - LGV / PCV

Practical training to prepare the trainee for the LGV Cat C1, C, C+E, D1, D or D+E tests are usually carried out on a 2:1 basis over 5 days. The training takes place using the customer's own vehicle. If you have any specific requirements then please call **01282 687090** to discuss.

Initial Driver CPC Module 4 Practical Test Training is compulsory for new drivers who plan to drive professionally. The practical test is arranged during the 5-day licence acquisition course. Attending this training will ensure the driver is suitably prepared for the module 4 Test.

REVERSING ASSISTANT

The Reversing Assistant ("Banksman") course is designed for those with a responsibility for directing vehicles within loading bays / vehicle yards. This course is carried out at customer premises.

DRIVING ASSESSMENTS

Driving Assessments can be tailored to individual requirements and can help give an organisation a vital snapshot on its drivers' skills and knowledge. Driving assessments can be carried out on all vehicle types, using the customer's own vehicle. These assessments can range from one hour snapshots of a driver's abilities to full day in-depth assessments with corrective tuition. Please call to discuss your requirements.

STANDARD ASSESSOR

The Standard Assessor course is designed to train an experienced driver to be a dedicated "in house" assessor. It also serves to prepare them for higher level assessment training should they wish to progress further.
