The last 12 months has been turbulent for us all, staff, customers, and suppliers alike! We are however proud to have adapted to the new world whilst continuing to serve our customers throughout.



One of our biggest achievements during the latest lockdown was adapting to the delivery of our ADR (Carriage of Dangerous Goods by Road) course online. We were initially reluctant to do this due to the duration and the intensity of the training however to satisfy customer demand we invested in additional technology and staff training to make this happen!

Between February and March, we delivered 10 ADR courses online via zoom, successfully training over 90 candidates with a first-time pass rate of 98%. In all honesty, these facts and figures surprised us all as we were unsure of the impact and value of remote delivery for such a course.

Moving into May as the restrictions ease, we are bringing back face to face ADR training, however, we feel online courses are not going to disappear and we will continue to develop these to ensure they are engaging and interactive.

Some of our popular online courses include Dangerous Goods Awareness, IMDG, Driver CPC and Operator CPC Refresher. These courses are mainly 1-day in duration and helps employees access courses from anywhere in the country.

In other news, OCR announced their withdrawal from the Transport Management Level 3 qualification in December 2021 giving us 12 months' notice to seek an alternative awarding body. After thorough research we applied to CILT(UK) and are now pleased to be an approved centre so we can continue to offer the qualification. Please note, those customers who have yet to gain the full award under OCR, we will continue to provide exams until December 2021.

We have all adapted to a 'changing' environment over the last 12 months however more so for our employee Nigel, a long standing and valued member of the team as he has decided he is going to retire and will finish at the end of May! Nigel has been in the industry for over 40 years and has enjoyed 18 years at Specialist Training. Often learners call and enquire 'is the guy still there, the one with the caravan in the warehouse'. OPERATOR TRAINING

RTITB or Certificate of Competence courses are available on a weekly basis on a ratio of 3 trainees to 1 instructor. As stated in the PUWER Regulations it is a requirement for all supervisors of workplace equipment to receive adequate training.

INSTRUCTOR / EXAMINER TRAINING

We are an **RTITB** Forklift Truck Instructor / Examiner **approved** training centre in East Lancashire. This course aims to up-skill a member of staff to RTITB Instructor standard to prepare them to deliver accredited operator training.

Once an individual is qualified, they will be able to instruct and examine on trucks for which they hold the relevant operator's certificate.

The instructor qualification is valid for 5 years upon when they will be required to attend a refresher course.

TRANSPORT MANAGEMENT CERTIFICATE OF PROFESSIONAL COMPETENCE (CPC)

All applicants for an **Operator's Licence** for road haulage vehicles must demonstrate "**professional competence**". The most popular way this is achieved is by passing the Transport Manager Certificate of Professional Competence examinations.

Specialist will be offering this qualification to new candidates under CILT (UK).



CPC INTENSIVE COURSE

This 10-day intensive public course follows the latest exam syllabus, which is based directly on Regulation EC 1071/2009, includes exam preparation for the two examinations and is held at our approved training centre. Upon successfully passing the examinations, a certificate will be awarded by CILT (UK).

CPC REFRESHER / REGULATORY UPDATE COURSE

This 1 or 2-day intensive course is designed to update the knowledge of existing transport managers and other related transport professionals who already hold a CPC. Such training is recommended by the Traffic Commissioners as important in ensuring managers are "up to date" in their transport knowledge.

DANGEROUS GOODS





CARRIAGE OF DANGEROUS GOODS BY ROAD - ADR

This course is for drivers who transport regulated dangerous goods over certain load thresholds by road. Drivers must attend an approved course and pass an examination set by SQA. Certificates are valid for 5 years.

This course is modular and can include all classes of dangerous goods including Explosives and Radioactives. Our public course can be tailored so the drivers only need to attend the modules they require. The course can also count for up to a maximum of **28 hours of Driver** CPC training depending on the modules attended.

Since the introduction of **computer-based exams** (*currently only available at Accrington location*) the drivers have been able to get their results immediately after the course. This has been hugely successful and beneficial to the driver especially as the ADR card is published within 7 days.
