OPERATOR TRAINING

The PUWER (Provision of Use of Work Equipment) Regulations state all supervisors of workplace equipment need to receive **adequate**, **relevant training**.

INSTRUCTOR / EXAMINER TRAINING

FIRST AID AT WORK

INITIAL

This course is aimed at individuals who are new to First Aid or whose certificate has lapsed. It aims to provide the necessary **practical skills** and **confidence** to deal with a **first aid** incident within a **workplace setting**.

These skills are learnt via our hands on approach to training which involves lots of **role play scenarios**, to help keep up with the demands on first aiders.

TRANSPORT MANAGEMENT CERTIFICATE OF PROFESSIONAL COMPETENCE (CPC)

All applicants for an **Operator's Licence** for **road haulage** vehicles must demonstrate **"professional competence"**. The most common way to achieve this is by passing the **CILT** Transport Manager Certificate of Professional Competence examinations.

CPC INTENSIVE COURSE

This 10-day (9 days training plus 1 exam day) intensive public course follows the latest exam syllabus, which is based directly on Regulation EC 1071/2009. The course includes an exam preparation day for the two examinations, held at our **approved training centre**. Upon successfully passing the examinations, a certificate will be awarded by CILT (UK).

This qualification is aimed at individuals who want to:

- Enter the profession of Transport Manager, or
- Demonstrate their professional competence to meet Operator Licensing requirements.

Examination will be conducted **online**, in the comfort of your **own home** / **work environment**. The exam location must however be suitable for examinations, **without distractions**, using a computer with **camera capabilities**.

CPC REFRESHER / REGULATORY UPDATE COURSE






DANGEROUS GOODS

CARRIAGE OF DANGEROUS GOODS BY ROAD – ADR

This course is for drivers who **transport regulated dangerous goods** over certain load thresholds by road. Drivers must attend a **Department for Transport** (DfT) approved course and pass an examination set by SQA. Certificates are valid for 5 years.



Since the introduction of **computer-based exams**, which are expected to be **compulsory** from **April 2024**, **replacing all paper-based exams** the drivers will be able to get their results on completion of the full course. This has been hugely successful and beneficial to the driver especially as the **ADR card is published within 7 days**.

DANGEROUS GOODS SAFETY ADVISER – DGSA

The 5-day DGSA course provides attendees with an **extensive study** of the **National** and **International** Dangerous Goods Regulations. The course prepares the individual to sit the Scottish Qualification Authority (SQA) examinations which are held five times a year. The training is also a vital grounding for the preparation of an individual to carry out their duties as a 'real world' Dangerous Goods Safety Adviser.

The **Exam Preparation Day** is aimed at those who require **additional exam technique** practice. A valuable session for those who haven't sat formal examinations for some time.

THE PETROLEUM DRIVER PASSPORT SCHEME – PDP

This course is an in-work scheme for drivers working in the Petroleum Industry. Any driver completing their classroom training needs to be certain they will be able to complete their practical assessment within four months. The passport is renewed every five years, but also has an annual practical assessment and an annual classroom training requirement.

Dates can be arranged to suit your requirements, so please contact us.

ADR REGULATIONS – FOUNDATION LEVEL

This 2-day course is aimed at candidates who require a detailed understanding of the ADR Regulations and the ability to use them to validate Dangerous Goods consignments and problem solve situations as they arise. Often delivered as an incompany course, the trainer will focus on the consignments relevant to the candidates. It is recommended also for the candidates to be familiar with Dangerous Goods.

CARRIAGE OF DANGEROUS GOODS BY SEA - IMDG

This course is designed for employees involved in the **movement of dangerous goods in-scope** to the International Maritime Dangerous Goods (IMDG) Code. Our one day course provides an introduction to the Regulations, although more in-depth and bespoke courses are available. All courses meet the requirements of STCW Section B-Vc.

This CAA approved and certified course complies with the training requirements of the IATA Regulations and is designed for those responsible for arranging movements of dangerous goods by air. Personnel involved with Civil Aylat classification, packing, labelling and completing / signing off documentation would need to attend this course. Upon passing the course, candidates will be issued with a CAA approved Carriage of Dangerous Goods by Air certificate, valid for 2 years.

LITHIUM BATTERIES BY AIR

As the demand for wireless equipment and electrification increases so does the demand for the training around the safe transportation of lithium ion & metal cells and batteries by air.

NEW to our **public course training planner** for **2024** is the **CAA approved 2 Day Lithium Batteries** by Air course.

This course is aimed at personnel who are responsible for arranging movements of regulated lithium batteries / cells including those involved with classification, packing, labelling and completing / signing off documentation. Upon passing the course candidates will be issued with a CAA approved Carriage of Lithium Batteries by Air certificate, valid for 2 years.

LITHIUM BATTERIES – SECTION II ONLY

This 1-day course is suitable for those personnel who are responsible for the shipment of **Section II batteries only**. Whilst a large part of the IATA Regulations don't apply, **section 1.6** (65th edition) does, which requires 'any person preparing or offering cells or batteries for transport must receive adequate instruction on these requirements commensurate with the functions for which they are responsible'.

BANKSMAN

This course is suitable for those who have a responsibility for directing vehicles within loading bays / vehicle yards. It is held at customer's premises to enable the trainees to learn in the environment in which they will be working. A classroom and a suitable training area is required. Sessions can accommodate up to 3 people per ½ day.

YARD SHUNTING

This course is designed for those with a responsibility for **manoeuvring vehicles or trailers** around the Company's own yard. Training can be provided on a wide range of vehicles including the specialist shunting vehicles such as **Terberg, Tug or Prime Mover**. This course is carried out at customer premises using their own vehicles.

Training is suitable for new operators who may only have a car licence as well as experienced operators who may require refresher training.
