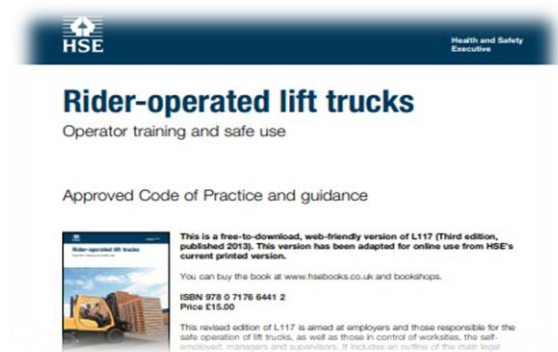




## FORKLIFT SUPERVISOR TRAINING

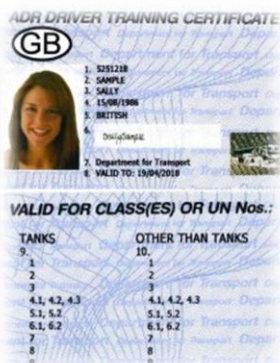

## DANGEROUS GOODS

### CARRIAGE OF DANGEROUS GOODS BY ROAD – ADR

**Ensure Safety, Stay Compliant, Transport Dangerous Goods with Confidence**

This course is designed for professional drivers who **transport regulated dangerous goods by road** above specified load thresholds. ADR training is a legal requirement under UK and International law for drivers carrying such goods, and this course ensures full compliance with the latest regulations.



Drivers must attend a **Department for Transport (DfT)** approved course and pass an examination. Once passed, certificates are valid for 5 years.



The course is modular, covering all **9 classes** of dangerous goods including Explosives and Radioactives. Our public course can be tailored so the drivers only need to attend the modules they require.

Attendance on the course can also count for up to a maximum of **28 hours of Driver CPC training**, depending on the modules taken.



Since the introduction of **compulsory computer-based exams in April 2024**, drivers can get their results immediately after the exam. This has been hugely successful and beneficial to the driver, especially as the **ADR card is published within 7 days**, for those who have successfully passed.

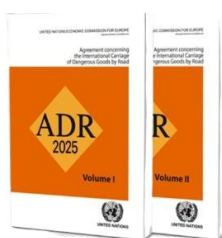

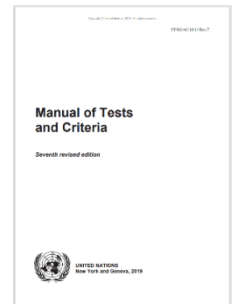

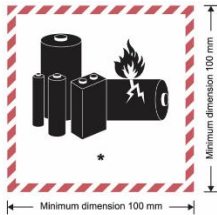

Whilst a large part of the IATA Regulations do not apply, **section 1.6** (66<sup>th</sup> edition) does, which requires ***‘any person preparing or offering cells or batteries for transport must receive adequate instruction on these requirements commensurate with the functions for which they are responsible’.***

This 1-day course is suitable for those personnel who are responsible for the shipment of **Section II batteries only**.

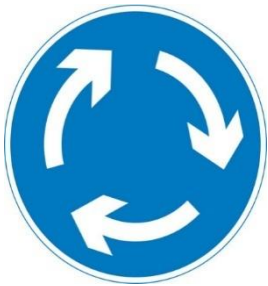

## DRIVER CPC

Stay Legal, Stay On The Road

**Year 1 of the 5-year cycle is almost complete!**  
**Attending 7 hours each year is the recommended route to keep on track!**  
**You have a choice between NDCPC and IDCPC – Do you know which is the best option for you?**

As most of you will be aware the government consulted during 2023, on making changes to Driver CPC, to make it more flexible. The outcome from the Consultation is the introduction of a **National Driver CPC (NDCPC)** from 3<sup>rd</sup> December 2024.

The new **NDCPC** will be more flexible as the required 35 hours can be spread over 3.5-hour blocks instead of the current 7-hour courses. The downside to the **NDCPC** is that if a driver attends any **NDCPC** they will only be issued an **NDCPC** card on completion of all 35 hours irrespective of whether they have attended any 7-hour courses!

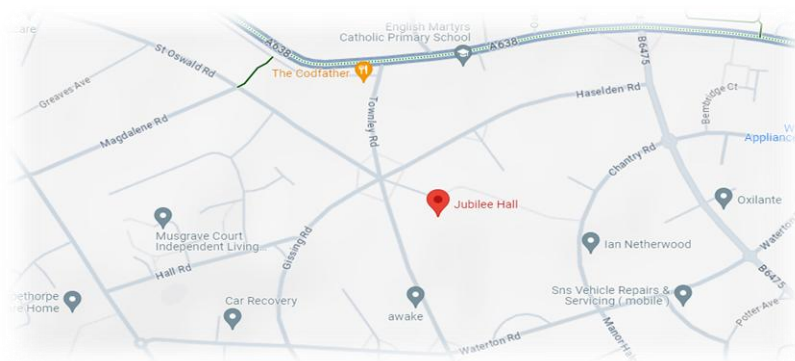
